Charles A. Dennis

1787 - 1844

At the time of his death in 1844 at the age of 57, Charles A. Dennis was Judge of the County Court of Pike County, Alabama, having been elected and posted bond in January of 1843. Survived

by his wife Esther and ten children, two of whom were minors at the time, the administration of his property continued at least until 1859 under his sons John W. Dennis and Michael M. Dennis and his son-in-law Simeon R. May.

Charles A. Dennis and Esther Maddox were married in October of 1805, probably in Hancock County, Georgia, as in September of that year, Esther's Father, Michael Mattox, gave to Esther a hundred acres. As evidenced in another earlier Hancock County Deed record of 1801, the wife of Michael Mattox was Jane Thomas. Mention of Michael Mattox and Jane Mattox is also found in the minutes of the Island Creek Baptist Church of Devereux, Georgia.

Charles and Esther evidently moved soon to Putnam County, as evidenced by various property transactions and clearly stated in the record of his service in the War of 1812 from Feb. 5 to Aug. 5 of 1815. In March, Lieut. Charles A. Dennis of Major Broadnax's Battalion of Georgia Militia received compensation for transportation to Fort Hawkins from Eatonton and back to Eatonton (Putnam Co., GA).

In the records of Autauga County, Alabama, Chas. A. Dennis first appears Feb. 1, 1819 as a Major, Seventh Regiment, Autauga County Militia. Then in September of 1819, he appears as a Representative from Autauga in the Legislature of the First General Assembly. Subsequently on Dec. 11, 1820, Charley A. Dennis appears as Justice cty Court, Cahawba. Cahawba was renamed Bibb County in late 1820 and Charles A. Dennis was a Senator from Bibb Co. 1821-2 and a Representative 1823-4. By 1826, Charles A. Dennis was in Pike County whence he was elected to the Legislature in 1826-7, 1827-8, 1829-30 and 1835-6. In August of 1828 Charles A. Dennis along with Abraham Miles and Benjamin Baldwin constituted the Commissioners of Monticello which subsequently in 1839 gave way to Troy.

Returning to September of 1844 on the occasion of dealing with the appraisal and administration of the estate of Charles A. Dennis, the Court issued Citation to appear to Esther Dennis, Widow of Charles A. Dennis and Michael Dennis, John Dennis, Joseph F. Dennis, William L. May in right of his wife Martha J., Simeon R. May in right of his wife Linna A., C.W. Pitts in right of his wife Mary A., Thomas Cargil in right of his wife Lucinda, and Levi Yon in right of his wife Nancy E. Not named are Serena M., age fourteen, who later married Paniel McCall and Charles A. who was eleven your add at the time.

eleven years old at the time.

Charles A. Dennis lies buried at the Dennis Family Cemetery located southeast of China Grove. According to her tombstone at Orion Cemetery of the Baptist Church at Orion, Esther was born 15 May 1790 and died 5 Feb 1870 at Orion. Interestingly, at the time of the U.S. Census of 1860 Esther appears at China Grove, Pike County in the household of her grandson, John W. Dennis, who was the oldest child of Esther's son, Michael M. Dennis.

On the 10th of September 1859 the Probate Court of Pike County authorized Simeon R. May and M.M. Dennis to dispose of real estate near China Grove in order to provide continued support for Esther and distribution of the estate to the remaining heirs in addition to Esther: M.M. Dennis, William M. May husband of Martha, Linna wife of (Simeon R. May), Joseph F. Dennis, Charles A. Dennis Texas, Nancy wife of Levi Yon Florida, S. McCall wife of D.A. McCall, and the minor heirs of W. Pitts dec'd Florida, also the minor heirs of Thomas Cargill Dec'd whose names are unknown residence supposed to be in Barbour County. John W. Dennis, one of the original administrators, is not mentioned because he had died in 1853.

That Charles A. Dennis had brothers in Putnam County, Georgia, is known from the will of Joseph Dennis, Jr. which was recorded in Putnam County Estate Records in 1815. Joseph Dennis gives land to his sons Matthias and Simeon Dennis with provision for his wife Ellenor during her lifetime. He also names his sons Charles A. Dennis and Matthias Dennis executors of his last Will and Testament.
